# Healthy Streets, Healthy Travel: Cleaner, Fairer Parking - Phase 2

February/March 2025











### **Overview**

Following a public consultation in October - November 2023, Camden Council's Cabinet approved proposed amendments to highway parking fees and charges and terms and conditions, subject to statutory consultation. You can read the decision report relating to this and our responses to the consultation feedback on our website at camden.gov.uk/ParkingPolicyReviewDecision.

In July - August 2024, we undertook the first phase of the traffic management order (TMO) consultations for 12 out of the 14 proposed changes. Approval was granted for making the TMO amendments and these changes have now been implemented. You can read the decision report relating to this on our website at camden.gov.uk/PPR\_Objections.

We are now undertaking the second phase of the TMO consultations, where necessary, for two proposals. Details of the current and proposed changes are set out in the tables below and details of how you can make representations in response to the statutory consultation can be found at the end of this document.
